



Application Form Completion Instructions

Even if you have applied before, PLEASE READ the following two pages carefully before you complete the application.

PLEASE NOTE: We DO NOT fund retrospectively and you are not eligible for financial assistance under this scheme if you have already purchased your instrument or if you do so after you submit your application but before we have approved it. If you submit your application and subsequently purchase your instrument (or receive assistance from another source for this purpose) you must inform us immediately.

Due to increased demand for our funds we strongly recommend you also apply to other bodies for assistance – on the Resources page of our website we have a list of ‘other charities that can help’ which may be of assistance. Please be sure to complete section 9a.

The deadline for applications to be considered at the next Trustees’ meeting in October is: **Friday 12th September 2012.** Any forms received after this date will be passed to the next meeting.

ABOUT EMI MSF

The Foundation is dedicated to the improvement of music education with a focus on youth.

ELIGIBILITY

**If you have settled status in the UK on 1 September 2011, meaning you are a British Citizen or have been granted leave to enter or remain in the UK for an indefinite period or you have a certificate of right of abode AND on 1 September 2011 you have been resident in the UK for a minimum of 2 years, then you are eligible to make this application.

RETURNING APPLICANTS

If you have applied before and been successful you are required to wait two Trustee meetings (approx 12 months) before you are able to re-apply. If you are in any doubt about these dates please contact the office.

Application Completion Steps

Every application will be considered solely on the basis of this form and any attachments taking into consideration need and the support of your independent referees.

Please complete each section of this form in full, carefully and clearly, using the check list on page 7 to ensure you have included everything we have asked for. Individual applicants under 16 may prefer to have their parents complete the form. However, please make sure that the form is completed in the child’s name. Parents will also need to sign the declaration under Question 11.

Additional documentation can be enclosed if it is vital to understanding your application, but please keep this to a minimum.

1. Supplier Quote

ALL APPLICATIONS for the intended purchase of musical instruments/equipment for both individuals and schools must be accompanied by **detailed cost estimates**, on supplier's original stationery or printed directly from the suppliers website. Schools applying for assistance with a workshop/training etc must also provide supporting quotes.

2. Reference (Individuals only)

Your application form must be supported with a reference from your music teacher. This should be included with your application form but if your teacher would rather send this under separate cover this is acceptable but please indicate this clearly on your form. Your application will not be processed (and duly acknowledged by the Foundation) until the reference has been received and it remains the responsibility of the applicant to ensure that a reference is sent prior to the application deadline. **This must be a supporting and substantial reference referring directly to your need for the instrument/equipment you are applying for. The reference must be dated and written on Personal Letterhead and should include the referee's FULL contact details and contact telephone number.**

3. Witness Statement

ALL APPLICATIONS must be witnessed. Applications from individuals need to be witnessed and signed by a professional third party (i.e. not a family member), known to you for at least three years – for example your doctor, teacher or bank manager. School applications should be witnessed by either the Head Teacher or a Governor. **Please be aware that from time to time witnesses are contacted to verify that they are fully aware of the details of the application.**

The Foundation acknowledges all applications in writing and you will be notified of the outcome of your application.
